GENERAL PURPOSE OF POST: To assist the Parish Priest, work with group leaders and volunteers to promote the evangelical mission of the Parish to children and young people.

- 2. To manage the parish social media
 - a) Facebook (in cooperation with the parish office)

- 3. To facilitate the Sunday evening Youth Mass (in cooperation with leaders)
 - a) Liturgy
 - b) Music (possibly setting up and running a music band)
- 4. To develop engaging faith based and social activities for the children and young people of the Parish which foster and promote the journey of faith for individual young people and their families.
- 5. To recruit, train and co-ordinate volunteers, especially young leaders. To work with established, organise and deliver new Parish programmes for children and young people including supporting formation for parents and carers.
- 6. To proactively promote participation and engagement to mass and the sacramental life of children and young people. To encourage young people to take an active role in the wider liturgical life of the Parish.
- 7. To maintain active consultation and communication with the Parish leadership, group leaders, volunteers, local schools, Deanery and Diocese and keep the wider Parish informed of new developments, initiatives and events that will enrich the overall Youth provision at Holy Family.
